# EUDR Update

After multiple years full of delays, uncertainty, U-turns and more questions than answers, we are now able to definitively relay the following message:

## **PRINTED BOOKS WILL NO LONGER FALL UNDER THE SCOPE OF EUDR!**

The (second) 1-year delay to the implementation date of EUDR has now been officially approved, now taking effect in December 2026. Further to this, a range of simplifications have been agreed – most notable for us is the removal of printed books, newspapers, pictures and other products of the printing industry, manuscripts, typescripts and plans, of paper, from the Regulation's scope.

Many of our customers have understandably been rather overwhelmed by the constantly changing nature of the EUDR legislation. Large periods of time passed with a lack of real clarity regarding with whom certain obligations lie, and as well as many being understandably concerned at the time and resources they would have to commit in order to fulfill their obligations, the potentially enormous penalties for non-compliance caused further panic. Just to compound these issues, the EU's own system was totally incapable of dealing with the masses of data, so there were legitimate concerns at all levels of the supply chain whether this was even going to be possible to roll out, let alone effectively.

While the majority in the print/publishing sector will be relieved to see the back of EUDR, we understand that many of our customers (and suppliers) put a lot of time, effort and money into preparing for compliance. Accordingly, we want to reiterate our commitment to the principles of EUDR, and we will continue our longstanding procedure of sourcing materials only from environmentally and ethically sound supply lines. We remain FSC certified, purchasing only FSC materials, as well as aligning our supply with the Book Chain Project Forest Sourcing database, purchasing only 5-Star rated paper and board.

We are certainly pleased for publishers around the world, (whether our customers or not) that were anxious about the very real possibility of having to pulp huge volumes of printed books either printed during the transition period or before, that may not have been able to comply with EUDR. This was a particularly difficult scenario to comprehend, given the financial and environmental waste that this would create, somewhat undermining the environmentally positive reasons behind the legislation.

While the rollout of EUDR has been laden with issues and created a lot of extra work for many businesses, the positive that has come from this has been an increase in transparency, traceability, and discussion among our entire supply chain. As ever, Bell & Bain will continue to operate sustainably and will be ready for whatever environmental legislation the future may hold.

# Mother Glasgow - Samira Cheraghi Painted by Gerard Burns

Friend of Bell & Bain and renowned Scottish artist Gerard Burns is launching a major new project in 2026 titled Mother Glasgow , a celebration of multiculturalism within the city and the essential role of women in our society. The project will feature 15 oil-painted portraits, each telling a powerful personal story rooted in Glasgow's diverse communities.

We are proud to share that our very own Samira Cheraghi was selected as one of the women to be painted, following a visit by Gerard to our factory.

Gerard explains the motivation behind the project:

"In all of the various exhibitions I've been involved in, both here in Glasgow and around the world, I've used my portraits to tell stories , whether about politicians, actors, individuals from the world of business and sport, or simply people who've come into my life for one reason or another.

In this case, each of these paintings and the subjects depicted has an important story to tell. Stories about the importance of immigration, of multiculturalism, and the role of women in our society , stories which matter now more than ever in these increasingly polarised times."

Samira moved to Glasgow in September 2021 and began working at Bell & Bain while adapting to a new country and language. Within six months, she was promoted and managed our advances/office copies that were to be sent to customers. Samira is now currently working in our estimating department, while still helping on the production floor when needed to stay closely connected to the work.

Samira shares her journey in her own words: "My academic background is very important to me. I hold a bachelor's degree in Applied Mathematics and a master's degree in Industrial Engineering. Before coming to Scotland, I worked in Iran as a Quality Assurance Engineer in both a car battery factory and an air-conditioning manufacturing plant. Those roles gave me strong technical experience, a systematic way of thinking, and a deep respect for precision. Although I had only a few months of English tutoring before moving, daily conversations and the kindness of people here helped me adapt quickly. Glasgow's green spaces, striking landscapes, and welcoming atmosphere have made it feel like a very good place to build a life.

I've noticed that some people know little about Iran, so I enjoy sharing its depth. It is a large, diverse country with many languages, rich artistic traditions, and thousands of years of history. Family, community, hospitality, and respect for elders sit at the heart of Iranian culture, and those values continue to guide me wherever I live."

The painting was unveiled in the factory, a moving and memorable moment for Samira and for all who were present. The portrait itself is outstanding, capturing both strength and warmth, and we are delighted to share it with you as part of this remarkable project.

As part of our Christmas tradition, we are delighted to once again host our Christmas Card Competition.


Choosing a winner is always very difficult and we'd like to thank all those who took part, if we could pick you all then we most certainly would!
